**Subject: Complaint Against the Israeli Government and Against the
Heads of the Ministry of Health**

The names of the government Ministers and their positions as well as the names of the heads of the Ministry of Health are listed at the end of this complaint.

I _____ ID _____ hereby submit a complaint against all Israeli government Ministers as well as against the heads of the Ministry of Health, for **deception, fraud, breach of trust and coercion of medical procedures** regarding the "Green Pass," as well as for manipulation of the definitions of the Ministry of Health, all in order to coerce the injection of the Pfizer preparation **BNT162b2** on the citizens of Israel and to coerce them into being experimental subjects in a clinical trial performed by a private pharmaceutical corporation.

And these are the grounds for the complaint:

1. The Israeli government is coercing all Israeli citizens through the use of the "Green Pass," in an obvious and violent way and **in violation of the Nuremberg Code**, to be experimental subjects in a clinical trial of a pharmaceutical corporation. Within the rules and regulations that the Israeli government has enacted and in which the "Green Pass" has been established, the government claimed that the purpose of the said "Green Pass" was medical, to prevent contagion. Lately it has become apparent that according to what has been said by the Minister of Health, the Minister of the Interior and even said by the Prime Minister, that it is **very well known to them that the language of the law as enacted by them, among others, is misleading and that the purpose of the "Green Pass" is not medical**, but punitive and its actual purpose is **to coerce the injection of the Pfizer preparation labeled BNT162b2**. In a speech on July 22, 2021, the Prime Minister defined the "Green Pass" as a punitive action.
2. The aforementioned speech made by the Prime Minister provoked a furious response from the Attorney General who explicitly stated that **"the use of the Green Pass as a sanction against the non-vaccinated is problematic."** In fact, the Attorney General stated in his announcement that the "Green Pass" is allegedly an act of fraud.



3. Section 13b of the Patients' Rights Law requires informed consent for every medical procedure. The Israeli government is breaking this law and coercing the injection of the Pfizer preparation by using the "Green Pass." **The Israeli government is using a punitive mechanism for the coercion of a medical procedure that will benefit a clinical trial of a pharmaceutical corporation, and this is instead of allowing all Israeli citizens the freedom of choice and decision.**
4. On August 4, 2021, the Minister of Interior, Ayelet Shaked, appeared in the media and declared out loud, in the studio of Channel 11 that: **"We need to tell the truth, the purpose of the Green Pass is not disease prevention but it's to encourage the non-vaccinated to get vaccinated."** And she added: **"The Green Pass does not prevent contagion."** This is an admission that the Israeli government is coercing a medical procedure on all Israeli citizens by means of the Green Pass. **This coercion constitutes assault with aggravated circumstances for all intent and purpose.**
5. And if this weren't enough, the Israeli government made an announcement that starting on the October 1, 2021, not only would the "Green Pass" be withheld from those who declined the first and second dose of the Pfizer injection, but in addition it would be withheld from those who already received two injections and from people who had recovered. **All those who declined the third injection would be punished through the termination of their Green Pass, meaning many of their rights as citizens would be denied, including the right to a livelihood; and these rights would also be denied from people who had recovered (!?). Regarding the latter, not only have scientific publications stated that people who have recovered have life-time immunity, administering the injection may pose a life threatening risk to them.**
6. Regarding the fraud, the heads of the Ministry of Health, among them **Nachman Ash, Sharon Alroy-Preis, Hezi Levi, Galia Rahav, Roni Gamzu,** and many others, are responsible for the manipulation of the definitions of the Ministry of Health to legitimize the coercion of the injection by the Israeli government through the use of the "Green Pass." Two such manipulations are detailed as follows:

- a. **The establishment of a very high threshold for the definition of a serious coronavirus patient, 94% saturation.** This is an extremely stringent classification when compared to the definitions used world-wide. By using this threshold, hundreds and thousands of patients were defined as serious cases when in fact their condition was not serious at all, and they were even released to their homes while still being defined as a “serious case.”
 - b. **Change in the definition of “vaccinated”** – from a person who was injected with two doses, to a person who received 3 injections of the Pfizer preparation, and this with the purpose of publishing false data in the media, which collaborated, that most recent coronavirus deaths were among “non-vaccinated.” The public has been convinced that they are referring to those who have not been vaccinated at all, while according to the data, they are also and perhaps mainly referring to those who have not received the third injection, and it is worth noting that the third injection has not been approved for use, not even via an Emergency Use Authorization by the FDA. Through this manipulation of the term “vaccinated,” 3 million citizens have been deceived and were injected with the Pfizer preparation without informed consent. Deception cannot coexist with knowledge, understanding or consent.
 - c. **Prevention of treatment with existing drugs – as in the darkest regimes, the entire media has been recruited to aggressively influence the public consciousness with the dissemination of data about morbidity, through the constant repetition of the numbers of serious and ventilated cases. At the same time, the Ministry of Health prevents hospitals from administering lifesaving drugs, such as those included in the medical protocol developed by Dr. Zelenko, the same physician who treated the former Minister of Health, Mr. Litzman, yet these are banned for “ordinary” patients who are not government ministers or close associates. It is only just to find out who is responsible from the Ministry of Health and/or the government for the prevention of treatment with efficient drugs, out of motives related to the disruption of the experiment in which the citizens of Israel have been recruited against their will. It is worth noting the obvious – the prevention of treatment with known and efficient drugs is comparable to premeditated murder.**
7. Allegedly, this is a case of fraud, coercion, abuse of office, and other serious offenses under the provisions in sections of the Penal Code, among them: 144.d.2; 192; 280; 281; 286; 300; 301.c; 304; 326; 378.
 8. **It is only right that Ministers of the Israeli government and the heads of the health system will be summoned for questioning and prosecuted for assaulting Israeli citizens in aggravated circumstances, coercion, threats, fraud, and deception all while abusing the power of office.**
 9. **Israeli citizens are being attacked by the Israeli government. It is the duty of the Israel Police to protect the citizens and investigate: Who gave the instructions? Who is**

responsible for the fraud? And to recommend to the Attorney's office to bring all those responsible to justice.

10. It is only right for all the Ministers to stand trial for deceiving the public and denying all Israeli citizens the right to choose with informed consent as to what is done to their bodies, and this was carried out through manipulation and coercion, while harming the livelihoods of hundreds of thousands of people and revoking their right to make an informed choice. They should also be prosecuted for causing death via negligence.
